

J&J SPRING SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN, OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

Non-winning entries will **not** carry forward into subsequent Entry Periods. The Administrator’s computer is the Sweepstakes official clock.

2. **ELIGIBILITY:** This Sweepstakes is open only to legal residents of the fifty (50) United States (**excluding Florida, New York, and Rhode Island**) and the District of Columbia who are at least twenty-one (21) years old at the time of entry. Employees of Sponsors, third party administrator (“Administrator”), and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, “Sweepstakes Entities”) and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the “steps” of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All federal, state, and local laws apply. **Void in Florida, New York, Rhode Island, and where prohibited or restricted by law.**

Participation constitutes entrant’s full and unconditional agreement to these Official Rules and Sponsors’ decisions and interpretations, which are final and binding in all matters related to the Sweepstakes. For purposes of the Sweepstakes, an entrant’s residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical addresses or e-mail addresses.

3. **HOW TO ENTER THE SWEEPSTAKES:** During the Sweepstakes Period, there are two (2) ways to enter:
 - A. **On-Premise QR Code:** Throughout the Sweepstakes Period, Sponsors will place Sweepstakes promotional materials at participating J&J locations. To enter the Sweepstakes, an entrant may visit a participating J&J location and scan the QR code on a Sweepstakes promotional material using a smartphone using a QR reader app (a QR app can be downloaded on an entrant’s smartphone, at no cost). **Note: each promotional material is designated for a specific day/Entry Period during the Sweepstakes Period, and will only be active during that Entry Period.** Upon scanning the QR code from a promotion material during the applicable Entry Period, an entrant must use his/her smartphone to complete and submit the registration form, which may include, but is not limited to, first and complete last name (no initials), street address (no P.O. Boxes), city, state, ZIP Code, e-mail address, telephone number, location, and confirmation that

entrant is at least twenty-one (21) years of age and has read and agrees to be bound by these Official Rules.

Upon submission of the registration form, an entrant will receive one (1) entry into the applicable Entry Period.

IMPORTANT: Message and data rates may apply. Not all smartphone providers carry the service necessary to participate in this Sweepstakes. Entrants should consult their wireless providers' pricing plans. Consent not a condition of purchase.

- B. Mail-In Entry:** To enter via mail, an eligible entrant may hand-write his/her complete name (no initials), valid e-mail address, street address (P.O. Boxes not accepted), city, state, ZIP code, telephone number, and date of birth (MM/DD/YYYY) on a 3½"x5" card ("Mail-In Entry") and mail it in a business sized envelope with sufficient postage to: J&J Spring Sweepstakes, P.O. A Mail-In Entry will be entered into the drawing for the Entry Period corresponding to the Mail-In Entry postmark date and must be received prior to the applicable Drawing Date in order to be eligible (Mail-In Entries received after the applicable Drawing Date will be entered into a subsequent Entry Period, if possible). Mail-In Entries must be legibly hand-written. Mechanical reproductions, postage-due, and Mail-In Entries sent in excess of the entry limits set forth below will not be accepted. Mail-In Entries received without a verifiable and legible return address will be deemed incomplete and not valid entries.

Entry Limits: Regardless of the method of entry, limit one (1) entry per person per Entry Period. If entries are received from the same person, e-mail, or phone number in excess of the stated limits, that entrant's entries may be considered invalid, at Sponsors' discretion.

- 4. RANDOM DRAWINGS:** On or about each Drawing Date listed in Section 1, the Administrator will randomly select one winner from all eligible entries received in the applicable Entry Period. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

5. PRIZES, APPROXIMATE RETAIL VALUE ("ARV"), AND ODDS OF WINNING:

A. Prizes (35 total; 1 per Entry Period): Each "Prize" is a \$5,000 check made payable to a Prize winner. Thirty-five (35) total Prizes are available in the Sweepstakes (one [1] per Entry Period). The ARV of each Prize is \$5,000.

B. ARV: The total ARV of all prizes available in the Sweepstakes is \$175,000.

C. Odds of Winning: The odds of winning a Prize depend on the number of eligible entries received for each Entry Period.

If a potential winner is disqualified, found to be ineligible or not in compliance with these Official Rules, does not

complete the required paperwork, or declines to accept a Prize, the Prize may be forfeited. If a Prize is forfeited, the Prize may be awarded to an alternate winner, selected in a random drawing from among all remaining eligible entries, as determined by Sponsors in their sole discretion. If, after a good-faith attempt, Sponsors are unable to award or deliver a Prize, the Prize may not be re-awarded.

Prizes are non-transferable and no Prize substitution, exchange, or cash equivalent will be allowed, except by Sponsors, who reserve the right to substitute a prize of equal or greater value in case of unavailability of the Prize or force majeure, at Sponsors' sole and absolute discretion. Sweepstakes Entities shall not be held responsible for any delays in awarding a Prize for any reason. Sponsors will issue an IRS Form 1099-MISC to each winner.

LIMITATION OF LIABILITY:** By participating in this Sweepstakes, entrants agree that the Sweepstakes Entities and each of their respective affiliates, subsidiaries, representatives, consultants, contractors, legal counsel, advertising, public relations, promotional, fulfillment and marketing agencies, website providers and each their respective officers, directors, stockholders, employees, representatives, designees and agents ("Released Parties") are not responsible for: (i) lost, late, incomplete, stolen, misdirected, postage due or undeliverable e-mail/text notifications or postal mail; (ii) any computer, telephone, satellite, cable, network, electronic or Internet hardware or software malfunctions, failures, connections, or availability; (iii) garbled, corrupt or jumbled transmissions, service provider/network accessibility, availability or traffic congestion; (iv) any technical, mechanical, printing or typographical or other error; (v) the incorrect or inaccurate capture of registration information or the failure to capture, or loss of, any such information; (vi) any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Sweepstakes; (vii) any injury or damage, whether personal or property, to entrants or to any person's computer related to or resulting from participating in the Sweepstakes and/or accepting a prize; or (viii) entries that are late, forged, lost, misplaced, misdirected, tampered with, incomplete, deleted, damaged, garbled or otherwise not in compliance with the Official Rules. In no event will more prizes be awarded than are stated in these Official Rules. In the event that, due to technical, typographical, mechanical, administrative, printing, production, computer or other errors, there are more winners than are stated in these Official Rules, a random drawing among the claimants will be held to determine the winner.

DISPUTES:** THIS SWEEPSTAKES IS GOVERNED BY, AND WILL BE CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF MICHIGAN, AND THE FORUM AND VENUE FOR ANY DISPUTE SHALL BE IN THE OAKLAND COUNTY, MICHIGAN. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY JAMS IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("JAMS RULES"). THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN MICHIGAN. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN OAKLAND COUNTY, MICHIGAN. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR SWEEPSTAKES ENTITIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION. ANY DEMAND FOR ARBITRATION MUST BE FILED WITHIN ONE (1) YEAR FROM THE END OF THE SWEEPSTAKES PERIOD, OR THE CAUSE OF ACTION SHALL BE FOREVER BARRED.

If it is discovered that a person has registered or attempted to register more than once using multiple phone numbers, e-mail addresses,

residential addresses, multiple identities, IP addresses, use of proxy servers, or like methods, all of that person's entries will be declared null and void and that person will not be awarded any prize that he/she might have been entitled to receive. Any use of robotic, automatic, macro, programmed, third party or like methods to participate in the Sweepstakes will void any attempted participation effected by such methods and the disqualification of the individual utilizing the same.
